## constitution

- NAME: 1(a) DEEPINGS BOWLING ASSOCIATION
  - 1(b) The Association shall have security of tenure of land by means of a lease from the Lincolnshire County Council.
  - The Association is a voluntary organisation operated for its members by its members and is not constituted or operated for profit.

OBJECT:

To foster and promote the sport of lawn bowls at all levels, providing 2. opportunities for recreation and competition.

MEMBERSHIP:

- Open to all and no application will be refused on other than 3(a) reasonable grounds, e.g. there will be no discrimination on grounds of race, occupation, religious or other opinion.
- The following classes apply 3(b)Full member Junior member – up to and including the age of 16 years.

SUBSCRIPTION:

All members shall pay an annual subscription determined at the Annual General Meeting. This subscription shall be due for payment on the Ist January each year payable during the period to the 30th April. Members in default by 1st May shall be deemed to have resigned and shall not be eligible for selection to the League teams.

MANAGEMENT COMMITTEE

- 5. The management of the Association shall be entrusted to a Committee elected at the Annual General Meeting and composed from members representing those using the facility. All members of the Committee shall serve for one year and be eligible for re-election.
- 5(a) The Management Committee shall consist of the following Officers: Chairman, Vice-Chairman, Treasurer, Secretary, Competition Secretary and In addition to the above Officers, the Management Social Co-ordinator. Committee shall consist of four General Members elected from full members of the Association.
- All nominations or proposals must be signed by a proposer and 5(b)seconder and submitted to the Associations' Secretary at least 21 days prior to the date of the Annual General Meeting and sent to all members 14 days prior to the meeting.

Should there be insufficient nominations put forward for General Members, the Committee shall be able to co-opt from full members of the Association to fill any such vacancies. Any member so elected shall retire at the next General Meeting.

The election of Management Committee Officers and General Members shall be by ballot.

- 5(c) The quorum for a meeting of the Management Committee shall be two thirds of the total number of Officers and General Members. will be by a show of hands unless deemed otherwise by the Chairman of the meeting. Each member shall have one vote but in the event of an equality of votes the Chairman shall have a casting vote.
- 5(d) The accidental omission of the Secretary to send a notice of a meeting to a member shall not invalidate that meeting.
